OFFICE ORDER

Subject: Constitution of Steering Committee for implementation of Extended Producer Responsibility for Used Oil under the Hazardous and Other Wastes (Management and Transboundary Movement) Amendment Rules, 2023-reg.

1. The Ministry of Environment, Forest and Climate Change (MoEF&CC) has amended the Hazardous and Other Waste (Management and Transboundary Movement) Rules, 2016 vide notification dated 18th September, 2023 to implement the Extended Producer Responsibility for Used Oil.
2. As per provision stipulated under Rule 42, Central Pollution Control Board hereby constitutes the Steering Committee to oversee the implementation of Extended Producer Responsibility for Used Oil with the following members:

3. The Term of Reference (ToR) of the Steering Committee would be as follows:
 - i. The Steering Committee shall be responsible for overall monitoring and supervision of implementation.
 - ii. The Steering Committee shall review and revise the targets, weightage and permissibility of modes of recycling in view of the technological advancements and other factors and make recommendations to the Central Government.

- iii. The Steering Committee shall decide upon the disputes arisen from time to time on the representations received in this regard, and shall refer to the Central Government any substantial issue arisen or pertaining to provisions of Chapter VII of the HOWM Amendment Rules, 2023.
- iv. The Steering Committee shall take all such measures, as it deems necessary for proper implementation of provisions of Chapter VII of the HOWM Amendment Rules, 2023.
4. The Steering Committee may also co-opt any other member if it considers necessary.
5. The tenure of the Steering Committee shall be for a period of March 31, 2025 and shall continue thereafter till re-constitution.
